Proposed Action: Establishment of Medical Oriented District (MOD)

and redevelopment of two development sites within

the MOD

NOTICE TO INVOLVED AGENCIES THAT LEAD AGENCY MUST BE DESIGNATED WITHIN THIRTY (30) DAYS OF JANUARY 26, 2018

This Notice is issued pursuant to Part 617.6 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law to designate a lead agency.

LEAD AGENCY DESIGNATION

Under the applicable standards of SEQR 6 NYCRR Part 617.6(b), the Town of Cortlandt Town Board concludes that it should be designated as the lead agency in the coordinated environmental review of the proposed action. This notification is being sent to involved agencies with the request that you consent to our agency serving as lead agency. If, however, you do not agree, you may follow the procedures outlined in 6 NYCRR 617.6(b)(5).

This Notice is being mailed on **January 26, 2018.** We would ask that each involved agency fill out the annexed form either consenting or not consenting that our agency serve as lead agency and return it on or before **February 26, 2018.** Responses should be sent to the within named contact person, who may be contacted for further information.

IF YOU DO NOT RESPOND WITHIN THIRTY (30) DAYS, IT WILL BE INTREPRETED AS CONSENT THAT THE TOWN OF CORTLANDT TOWN BOARD SERVE AS LEAD AGENCY. YOU WILL CONTINUE TO BE NOTIFIED OF SEQR DETERMINATIONS AND ANY LATER PROCEEDINGS AND HEARINGS, AS PROVIDED BY LAW.

<u>Description of Action</u>: The Proposed Action is: 1) the adoption of a Medical Oriented District (MOD) in the area surrounding the existing New York Presbyterian Hospital (NYPH) facility to support the creation of a mixed-use commercial center; and 2) the redevelopment of two sites within the MOD with a mix of medical, residential, and commercial uses.

Medical Oriented District

Sending this Notice:

The Town of Cortlandt is proposing to establish an optional "Medical Oriented District (MOD)" along Route 202/35 in the area surrounding NYPH generally bounded by the municipal boundary with the City of Peekskill to the west and Conklin Avenue to the east (see Figure 1). Property owners with eligible parcels in this district can apply to receive a MOD campus designation which can be affixed to a qualifying parcel of land. Once a parcel receives MOD campus designation, the parcel is governed by the use, dimensional and other provisions of the MOD zoning regulations and MOD zoning replaces the existing zoning. The intent of the MOD is to encourage economic revitalization in the area surrounding the hospital center and to enable and implement the goals and recommendations outlined in the Town's 2016 Sustainable Comprehensive Plan titled "Envision Cortlandt." It is further the intent of this district to provide a continuum of care and allow patients access to a wide range of health services and other complementary uses in one central area with the look, feel and function of a future "Town Center."

Proposed Redevelopment

The Proposed Action also includes two mixed-use development proposals on two sites comprised of several parcels within the proposed MOD (see Figure 2). The two sites shall be referred to as the Gyrodyne Site and the Evergreen Site. These sites are proposed to be redeveloped with a mix of medical, residential, and commercial uses.

Gyrodyne Site

The Proposed Project would include the redevelopment of eight contiguous parcels totaling 13.8 acres with 100,000 sf of medical office, 4,000 sf of complementary retail, 200 residential units (10% studio, 10% 2-bedroom, and 80% one bedroom), 180 structured parking spaces and 383 at-grade parking spaces. The proposed new development would replace the existing medical office buildings (33,000sf) and single-family home on the site. The development would also include a publicly accessible hamlet green and plaza area, publicly accessible open space around Orchard Lake, pedestrian pathways, sidewalks along the Route 202 frontage, landscaping, and a new transit stop.

Evergreen Site

The Proposed Project would include the redevelopment of three vacant contiguous parcels totaling 28 acres with 120 assisted living units, a hotel with 100 rooms, 22,000 sf of complementary retail, 120 residential units (20 studio, 75 one-bedroom, and 25 two-bedroom), and 402 parking spaces.
