TOWN BOARD REPORTS

Councilmember Costello gave her report

OF NOTE:

 Explained the history and the progression of the Croton Arboretum Sanctuary of which Councilmember Costello is the liaison for the Town of Cortlandt

Councilmember Becker gave his report

OF NOTE:

- Discussed Indian Point making the following points:
 - 1. There are 2 Indian Point task forces, one created statewide by the Governor, and one local task force both of which meet regularly regarding the pending closure.
 - 2. There are 2 areas of impact, public safety and economic. Councilmember Becker stated that Entergy feel secure with the storage of the rods and the occurrence of the pipeline affecting Indian Point but took no stand with Indian Point affecting the pipeline, a gas and pressurized large pipe. With the issue of economic, the Board wants to be clear that the Town itself will be very viable and don't anticipate much of a Town tax change. The school budget will be affected and school taxes will go up significantly. The School Board has to deal with and prepare for this.
 - 3. Councilmember Becker commented that the State has a responsibility and we must implore them and convince them to assume that financial liability. The State must compensate the Town and the Federal government must also take responsibility for the rod storage and the loss of revenue.

TOWN BOARD REPORTS, (cont.)

Councilmember Creighton gave his report OF NOTE:

- Discussed letter drafted by the Town with a resolution opposing anything that would stop the free flow of the Hudson River. Councilmember Creighton urged residents to write their concerns.
- Film companies have come to Cortlandt and there is a public hearing tonight to enact a film law to not impact the neighbors. There is a video made at the Town about Veterans being shown in Time Square.

Councilmember Farrell gave his report OF NOTE:

- Regarding Cortlandt Crossing, Councilmember Farrell stated he was impressed with the care and effort that went into addressing the concerns that were raised by the Town and Planning Boards in addressing the impact of a project this size. Many problems in this area were solved by this project also at the builder's expense and many job opportunities.
- There will be a "Meet and Greet" open house for senior citizens at the Community Center for newcomers. There are many programs available for seniors and Councilmember Farrell urged residents to call the Director of the Senior Citizens.
- Cortlandt Rowing Club is training for upcoming races and it is a very successful program. Councilmember Farrell thanked everyone for their support.
- Councilmember Farrell acknowledged the frustration residents feel regarding traveling on Route 9A with the new gas line being installed by Con Edison and the lengthy clean up of the gas station. He hopes to persuade NY State to implement some traffic improvement when the repaying begins.

PUBLIC HEARING, (cont.)

The Town Clerk read the Notice of Hearing and presented its Affidavit of Publication from the official Town newspaper.

Supervisor Puglisi called the hearing to order at 7:41 p.m.

Tom Wood stated that from time to time companies contact the Town and indicate they want to film in some part of the Town, sometimes its in private homes, sometimes they request the use of a Town road or park, etc. By this Local Law, the Town Board is going to formalize the policy for regulating it within the Town. It will be known what is occurring and will explain it to the neighbors and will require insurance to be in affect. It also helps us enforce a NY State building code which requires the Town to insure any Department of Labor inspection or any electrical inspection is conducted. Most instances the permits will be handled administratively and it also provides that if a film company seeks to use one of our parks or roadways, the Town Board would set certain conditions or standards on it including compensation to the taxpayer for being excluded from the use of that road or park for a period of time. If any town personnel or police services were required that would be fully recouped

Supervisor Puglisi added that anything for Veterans and Scouts, the fees would be waived.

A motion to close the Public Hearing at 7:45 p.m., adopt a Negative Declaration and Adopt Resolutions was made by Councilmember Becker and seconded by Councilmember Creighton.

it and to make it safe. This property is located on 9 South Mt. Pass Road. Notices have been sent since January 2016. The last notice of this hearing was returned as the property owner is no longer accepting or receiving mail.. The Town engineer has submitted to the Town Board a report indicating that it is in his opinion that the structure is unsound and by this proceeding the property owner will then be given 10 days within which to assure us by coming in with commitments to remedy the situation themselves. If not, then the Town will secure a contract to enter the property, demolish the structure that is unsound and then lien back on the property on the next tax bill.

Supervisor Puglisi commented that the Town doesn't do this lightly
