

Re: Sept. 19, 2013 referral regarding Letter from Daniel Goudreau for parcels on 6th St., Verplanck, NY

I have met with and spoken to Dan on a number of occasions regarding the adjacent property at 189 6th St. A property maintenance violation was first issued on 4/24/12. It was returned marked "deceased". A second copy was mailed c/o Paul Harding at a Manhattan address. There was no response.

The taxes are in arrears and there is no bank involved. In a follow-up inspection in May, I found a real estate sign on the property and called the agent. He confirmed the house was for sale, but there were family issues regarding disposition of the property, so he could not give me the owner information.

In a follow-up call to the realtor in August, I was able to obtain a contact, Jennifer Tiernan-Bindler. I called her about the property maintenance issues and she complained that any rodent problem is due to Mr. Goudrou's tenants leaving uncovered garbage cans in front of the property, which I observed several times. She emailed on 8/19 that she would address the excessive plant growth right away.

On 8/21 she emailed - "we do have a rodent problem because of his garbage but I will have extermination done as well... as long as he is taking steps to fix the underlying issue." I relayed this information to Dan, who told me he had purchased new, covered garbage cans, which I confirmed. The realtor called me to advise they are close to signing contracts for the sale of the house, which may be closed within 30-60 days.

I did an inspection on 9/20 and found some of the vegetation had been cut, but more needed to be done. On 9/23 I was able to reach Jennifer, who said she would have someone do more yard work. She told me there are signed contracts for the sale of the house, which I confirmed with the real estate agent.

Sixth Street Speeding

As directed by the Town Board, this office reviewed the request by Ms. Lois Ann Nelli to address speeding and the request to install STOP signs along both Sixth Street approaches to Riverview.

This location does not meet the required State and Federal warrants for the installation of stop signs along Kings Ferry Road/Sixth Street. Riverview is a one-way roadway away from the intersection at this location, thereby creating a situation where there is no reason for motorists to stop.

However, in an effort to combat speeding, speed measurements were taken at this location prior to the end of the school year. The average speed was found to be greater than the posted speed limit which confirms Ms. Nelli's observations. The speed trailer was deployed earlier in the year and the Town Board authorized the installation of a permanently mounted speed display (driver feedback) sign along Kings Ferry Road west of Sunset Road. Approvals from Con Edison are currently being sought for the installation.

Two courses of action were recommended as countermeasures for speeding along this straightway:

- 1. Installation of either the Town's or Westchester County trailer mounted speed display (driver feedback) sign as a temporary measure. Both were installed along the straightaway.
- 2. Request from our partners at the New York State Police and Westchester County Police for visible, targeted speed detail along that section of roadway. County police have conducted speeding detail along the straightaway.
