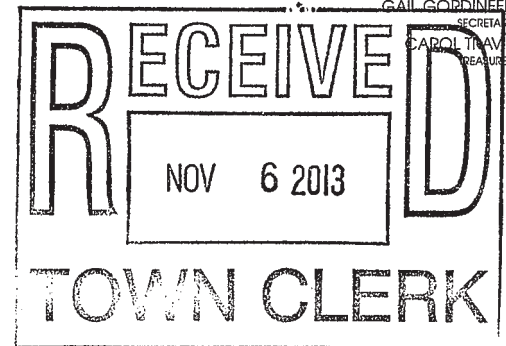

FIRE DISTRICT ELECTION

PLEASE TAKE NOTICE, that the Annual Election of the Lake Mohegan Fire District will take place on December 10, 2013, between the hours of 6:00 PM and 9:00PM at the Jefferson Valley Fire Station located at 500 Lee Blvd., Jefferson Valley, N.Y. for the purpose of electing one Commissioner for a 5 year term commencing on January 1, 2014 and ending on December 31, 2018. 175 AND 176 OF THE TOWN LAW OF THE STATE OF NEW YORK

NOTICE IS HEREBY GIVEN, that pursuant to Section 175 of the Town Law the annual election of Fire District Officers for the Montrose Fire District will be held at the Montrose Fire House, 2/43 Albany Post Road, Montrose, New York, on the 10th day of December, 2013 between the hours of 6:00 P.M. and 9:00 P.M., Prevailing Time.

One Officer, Fire Commissioner, is to be elected, for a term of five (5) years commencing January 1, 2014.

Every elector who is a registered voter under personal permanent registration and a resident of the Fire District for 30 days next preceding the annual Fire District election shall be qualified to vote and to hold office.

The polls will be open for the receipt of ballots from 6:00 P.M. to 9:00 P.M., Prevailing Time, on December 10, 2013.

PLEASE TAKE FURTHER NOTICE, that pursuant to Section 176 of the Town Law candidates for District Offices shall file their names with the Secretary of the Montrose Fire District at least ten days prior to the date of such Fire District election, and in addition, such nominations shall be submitted in Petition form subscribed by 25 qualified voters of the District.

ALL completed Petitions shall be submitted and filed at the Montrose Fire House, 2/43 Albany Post Road, Montrose, New York at least ten days prior to the date of the Fire District election.
