As a follow up to your discussion yesterday with my paralegal, Jeanene Chambliss, we are respectfully requesting an adjournment of the May 1, 2018 Planning Board meeting in connection with the captioned matter. As you are aware, our office timely filed a request for Recertification of the Special Permit for the existing New Cingular Wireless PCS, LLC (AT&T) wireless telecommunication facility located at 451 Yorktown Road, Croton on Hudson, New York. As you are also aware, we received an extensive review memo from Michael Preziosi, P.E., Director, Department of Technical Services, in connection with this matter.

On April 12, 2018 our office met with Mr. Preziosi and the Town Attorney, Thomas Wood, to discuss the review memo in more detail and to confirm the final items to be addressed by our client. At this time, AT&T is working on responses to these final items.
