Local Law No. ___ of 2022

(A LOCAL LAW TO AMEND LOCAL LAW NUMBER 5 OF 2021 REGARDING ENHANCED VETERANS EXEMPTIONS)

Section 1. Legislative Intent

The Town previously passed Local Law Number 5 of 2021 in order to ensure that Veterans in the Town receive the maximum property tax exemption as permitted by Law. Local Law Number 5 of 2021 used assessed values and this amended Local Law shall use real dollar amounts.

Section 2. Text Amendments In Real Dollar Values

The Town Code shall be updated to reflect the updated exemption amounts. The language in **bold** shall be added and the language that is stricken shall be removed:

- A. Qualifying residential real property, as defined in New York State Real Property Tax Law § 458-a, shall be exempt from taxation to the extent of 15% of the assessed value of such property; provided, however, that such exemption shall not exceed \$54,000 \$75,000 or the product of \$54,000 \$75,000 multiplied by the latest state equalization rate for the assessing unit.
- B. In addition to the exemption provided by Subsection A of this § 275-9.1, where the veteran served in a combat theater or combat zone of operations as documented by the award of the United States campaign ribbon or service medal, qualifying residential real property, as defined in New York State Real Property Tax Law § 458-a, shall be exempt from taxation to the extent of 10% of the assessed value of such property; provided, however, that such exemption shall not exceed \$36,000 \$50,000 or the product of \$36,000 \$50,000 multiplied by the latest state equalization rate for the assessing unit.
- C. In addition to the exemptions provided by Subsections A and B of this § 275-9.1, where the veteran received a compensation rating from the United States Veterans' Administration or from the United States Department of Defense because of a service-connected disability, qualifying residential real property, as defined in New York State Real Property Tax Law § 458-a, shall be exempt from taxation to the extent of the product of the assessed value of such property multiplied by 50% of the veteran's disability rating; provided, however, that such exemption shall not exceed \$180,000 \$250,000 or the product of \$180,000 \$250,000 multiplied by the latest state equalization rate for the assessing unit. For the purposes of this subsection, for a person who served in the active military, naval or air service during a period of war and who died in service of a service-connected disability, such person shall be deemed to have been assigned a compensation rating of 100%.

Section 3. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or

invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.

Local Law No. of 2022

(A LOCAL LAW TO AMEND LOCAL LAW NUMBER 3 OF 1996 TO SEPARATE THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT FROM THE DEPARTMENT OF TECHNICAL SERVICES)

Section 1. Legislative Intent

For decades, the Town has had a Department of Technical Services which encompasses Engineering Services, Code Administration and Enforcement, and Planning and Community Development. Planning and Community Development has morphed throughout time into a separate discipline which does not require a professional engineer to oversee its functions. The Town Board believes that now is the time to allow Planning and Community Development to be its own Department with its own Department Head.

Section 2. Amendments to Local Law 3 of 1996 and Local Law 8 of 1997

The Department of Planning and Community Development, also known as the Department of Planning and Community Improvement, shall be its own Department with its own Department Head.

Section 3. Department Head

The Director of Planning shall be the Department Head.

Section 4. Current Provisions

All laws, ordinances, rules and regulations pertaining to "Planning", "Planning Division", or "Planning Board" shall be the responsibility of and duty of this Department.

Section 5. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.



Senior Citizen Clubs:

The spike of Covid cases due to the Delta and Omicron variant and the precarious nature of this population greatly influence the fluctuation in participation. The pandemic has cancelled some of the weekly club meetings that fall under Senior Citizen Programming for the month of January but they are on the rise. We did have 7 large club meetings this month with approximately **64** in attendance at each. Verplanck Seniors continue to meet at the Schoolhouse each week.

Nutrition Program:

The Home Delivered Meal Program is sporadic in nature, due in part to the fragile health of those involved. It has seen a slight decrease in the averages from last year.

The Congregate Meal Program varies in accordance with the menu as put forth by Westchester County Senior Programs and Services. We continued and increased the number of congregate meals this month, in addition to the GRAB & GO meal service.

Other Services:

This month, our numbers continue to increase across the board, as more programs are resuming. We had Covid-19 test kit distribution to the town's seniors this month and gave away 500 in all. We added a new program to our activities, indoor Pickleball. There has been a great turnout having teams of 4 playing each Monday from 11am-3:30 Pm. In addition, I've attached our monthly January calendar so you can reference.



Dear Supervisor and Town Board Members:

As attorneys for Jonas Bastys, Inc. (the "Sewer Company"), we submitted to the Town in September 2020, a petition on behalf of the Sewer Company seeking an increase in sewer rates pursuant to Section 121 of the NYS Transportation Corporations Law (the "Petition"). As set forth in the Petition, the last sewer rate increase was approved by the Town in <u>June</u>, 1991. Notably, there was a question of whether the Town Board timely rejected the Petition. In the meantime, we have been working with the Town Attorney and Director of Technical Services on a possible agreement for the Town to acquire the Sewer Company's facilities.

While we are working on the terms of such an agreement, it has been acknowledged that the Sewer Company's operational costs have increased since its last rate increase in 1991 and the Sewer Company has made, and continues to make needed plant upgrades. As such, we were asked to resubmit the Petition, as is, for consideration by the Town Board while the terms of an acquisition arrangement can be negotiated.

Accordingly, we are hereby re-filing with you 5 copies of the Petition <u>as submitted</u> in 2020, seeking to increase sewer rates pursuant to Section 121 of the Transportation Corporations Law. The original signed copy is already in the Town's possession. The customers of the Sewer Company are set forth on Exhibit A of the annexed Petition.

While the Transportation Corporations Law does not require the Sewer Company to notify customers of a proposed increase in rates, the sewer Company will mail notification to each of its customers.

In short, the current rates charged by the Sewer Company are \$9.59 per 1,000 gallons of usage plus a \$14.00 per unit sludge charge. Significantly, these rates have not changed since June of 1991. In light of extensive capital repairs and related expenditures over the past 28 years, the Sewer Company proposes a new rate of \$10.59 per 1,000 gallons of usage starting with 3Q 2020 billing, with quarterly increases of \$1.00 per 1,000 gallons of usage, for the next 4 years.

According to the statute, the Town need not take any action on this application. If the Town chooses not to act, the rates would become effective in 90 days from the date of this Petition. In order to avoid any confusion, the Sewer Company proposes that the requested rates become effective retroactive to September 30, 2020.

The Sewer Company will assist the Town in its review of this Petition. If there are any questions or if we can be of any assistance, please contact the undersigned.

The Petition of Jonas Bastys, Inc. ("JB Inc") states upon information and belief:

- 1. JB Inc. is a New York Corporation incorporated in 1969 pursuant to the Transportation Corporations Law of the State of New York with an address of 1 Baltic Place, Suite 205, Croton-on-Hudson, NY 10520.
- 2. JB Inc. owns and operates the Baltic Estates Wastewater Treatment Facility ("WWTF") located in the Town of Cortlandt, New York, pursuant to Article 10 of the Transportation Corporations Law and in accordance with the rules and regulations of the New York State Department of Environmental Conservation ("DEC") and New York City Department of Environmental Protection ("DEP").
- 3. The WWTF currently serves various co-op associations, condominiums, single family homes, pools, and commercial buildings as indicated on Exhibit "A". A map depicting the current sewer service area and WWTF is attached as Exhibit "B".
- 4. The current sewer rate charged to all users serviced by the WWTF is \$9.59 per thousand gallons of usage_based upon the rate charged by the Northern Westchester Joint Water Works, the New York City Raw Water Rate, and the Town of Cortlandt for water usage, and an additional \$14.00 sludge charge per unit as approved by the Town of Cortlandt Resolution 130-91 dated June 4, 1991.
- 5. On or about February 12, 2014, the Westchester County Bureau of Environmental Quality issued an inspection report and notice of noncompliance. A copy of the inspection report and notice of noncompliance is attached as Exhibit "C". The WWTF is currently in need of repairs and requires immediate upgrades to meet the requirements of Chapter 873, Article XXII, Section 873.2207 of the Laws of Westchester County.
- 6. The repairs include, but are not limited to, repairing the front roof and back wall of the WWTF, upgrade hand rails, upgrade alarm systems, placing chemical crocks within a containment area, installation of baffle, and replacement of sludge pumps/tanks.

- 7. Based upon the necessary upgrades required, JB Inc. sought proposals to determine the most cost-effective upgrade project estimate and engaged Cedarwood Engineering of Warrensburg, New York to prepare the necessary cost estimate. The work determined by Cedarwood Engineering as necessary to bring the WWTF in compliance with Chapter 873, Article XXII, Section 873.2207 of the Laws of Westchester County and the estimated costs of such work, is more particularly set forth on Exhibit "D" annexed hereto.
- 8. As is more fully detailed in the budget table prepared by Guy DiPietro of Fine Ciliberti & DiPietro, the accountants, annexed hereto as **Exhibit** "E", JB Inc. already invested significant sums in undertaking substantial capital improvements to its facilities through December 31, 2018. These improvements were made pursuant to the requirements of the DEC and the DOH at a total cost to JB Inc. JB Inc. has budgeted the additional sum of \$740,000.00 for fiscal year 2020 for the balance of the required repairs.
- 9. In order to perform the needed repairs to the WWTF, recover the costs heretofore incurred by JB Inc. for capital improvements, pay financing costs for same, and provide for current and ongoing operation and maintenance of the WWTF, JB Inc. hereby proposes to implement a one (\$1.00) Dollar increase per quarter, to be paid by each meter in the sewer district resulting in a new sewer rate of \$10.59 for 3rd quarter 2020, \$11.59 for 4th quarter 2020; and continuing said quarterly one (\$1.00) Dollar increase thereafter for the following 4 years, per one thousand gallons of usage. This represents a fair, reasonable and adequate rate for wastewater treatment and disposal because the sewer rate is directly related to the charge for service and the cost of upgrades, operating and maintaining the system.
- 10. Section 121 of the Transportation Corporation Law provides that sewer rates are to be agreed to between the Sewage Works Corporation and the local governing body. We believe that the increase requested herein is reasonable and adequate and we hereby request that the increase be agreed to in its entirety by the Town of Cortlandt. Your prompt consideration of this request would be appreciated, as time is of the essence to maintain the integrity of the Baltic Estates Wastewater Treatment Facility.

WHEREAS, it has periodically updated its zoning criteria and removed barriers to an owner's ability to obtain approvals for accessory apartments; and

WHEREAS, similarly, the Town is also supportive of a Transit Oriented Development (TOD); and

WHEREAS, the TOD was a major concept in the Town's Master Plan; and

WHEREAS, however, the State is currently considering legislation that would impose one-size-fits all approaches to both ADU and TOD; and

WHEREAS, the Supervisor and Town Board believe in Home Rule and believe that criteria for ADU and TOD should be left to the discretion of local elected officials who are best able to ascertain the needs of their communities; and

WHEREAS, while the Supervisor and Town Board believe that the legislation is well-intentioned, it cannot support the legislation as currently drafted;

NOW, THEREFORE, BE IT RESOLVED, that the Supervisor is authorized to send correspondence to the Governor and elected officials expressing concerns in relation to the currently proposed ADU and TOD legislation.

AN ACT to amend the real property law, in relation to accessory dwelling units; and to amend the executive law, in relation to including an accessory dwelling unit in the term housing accommodations in human rights law

The Conference of Mayors has reviewed this legislation and recommends that it be disapproved by the State Legislature. This legislation would mandate local governments to enact a local law allowing for the creation and occupancy of accessory dwelling units (ADUs) within their jurisdictions. The proposal would prevent local governments from "unnecessarily" impairing the creation of ADUs and would impose numerous limitations on the ability of local governments to regulate ADUs, including a substantial prohibition on the imposition of parking requirements.

While the goals of this legislation are laudable, this one-size-fits-all proposal is impractical, applying definitions and regulations on localities that have vastly disparate zoning schemes. This legislation would undoubtedly result in community conflict and real estate development that does not necessarily conform to well-considered comprehensive plans and zoning schemes.

State legislation that provides localities with the option of offering incentives for the creation of ADUs would be an acceptable method of addressing a lack of affordable housing. However, an imprecise mandate from the State, which is what this legislation would impose, is unlikely to achieve the desired results and would violate New York's longstanding practice of locally determined zoning policies.

For the foregoing reasons, the Conference of Mayors opposes this bill and recommends that it be disapproved.
